I agree to take full responsibility for myself and the animal I am riding. I release, hold harmless and indemnify the Eastern High Sierra Classic Ride Management, all ride owners over whose land the ride crosses for any and all liability arising from accident, injury or loss that might occur due to my participation in this ride.
