**Trail:** Single trace and 2 track, alternating flat and hills.  
Hoof protection recommended.

**Directions:** From Louisville, take I-65 North to Exit 19. Turn left on SR 160. From Indianapolis take I-65 South to Exit 19. Turn right on SR 160. Go approximately 5.5 miles and turn left onto Pixley Knob Road for 1.4 miles. Then turn right onto Flatwood Road for 1.4 miles and camp will be on your right.

**JUNIORS MUST WEAR HELMETS** AND ALL RIDERS ARE ENCOURAGED TO DO SO.

***Indiana Bridle tags are required to ride in the State Forest. I can get you a 1-day tag for \$5 if you send me the money by Oct. 21. If you are riding both days you would need one for each day.***
