We are so happy to have this opportunity of putting on this event. We will be selling raffle tickets for a variety of items that have been donated for this organization at camp

Here are a couple of things we wanted to inform everyone about, Camp will open at 12 pm on Friday, May 10th and will remain open till Sunday afternoon. The Land owners who have graciously opened their land up for camping are requesting a \$15 a day/ Per Rig Fee (cash or checks will be accepted at camp).

Check in will begin at 1pm Friday afternoon, Vetting will begin around 2pm. Fun riders can check-in either Friday night or Saturday morning starting at 8 am. Friday evening at camp there will be a food truck selling dinner. The Pre-ride meeting will be around 6pm.

50's will begin at 6:30 am on Saturday May 11th, 25's will begin at 7:30 am, and the first group of fun riders will be starting around 10am, then another group at 10:30, and at 11. Saturday's dinner will begin serving at 5 and the award meeting along with our raffle will be at 6:30 pm. Dinner is not included with the Fun Ride entries, sorry for the inconvenience.

Some Camp/ Ride rules; please respect the landowners requests and stay on marked trail, do not wander. Respect the land we are on, this is a special opportunity and we do not want to ruin it and not have the ability to be able to do this again. Do not bother any livestock (Sheep or Cattle). Keep dogs on leashes in camp. Respect our volunteers, as I am quickly finding out it takes a lot of help to be able to put on an event like this. In the packets I have put some comment forms, this is my first event as ride manager and I would love all the feedback we can get. If you could fill this form out and return to the ride office by the award ceremony or before you leave that would be very much appreciated. MOST IMPORTANTLY let's have a fun and safe ride! Keep this a drama free zone and enjoy the magnificent views of the Sutter Buttes.

Directions to Ride camp: 11114 Pass Rd. Sutter, CA 95982. (39.1861810, -121.8072106)

Coming north from Sacramento; Take Hwy 99 to Yuba City, Turn left on to Hwy 20(Colusa Hwy) towards Sutter. At the stoplight turn right onto Acacia Ave, this will bring you into the town of Sutter. This road will come to a bend and turn into Pass Rd. Stay on Pass Rd for 4 miles, Camp will be in a pasture on the left-hand side. I will have a sign up to warn about camp gate being close.

Coming South from Chico; Take Hwy 99 to Yuba City, Turn right on to Hwy 20(Colusa Hwy) towards Sutter. At the stoplight turn right onto Acacia Ave, this will bring you into the town of Sutter. This road will come to a bend and turn into Pass Rd. Stay on Pass Rd for 4 miles, Camp will be in a pasture on the left-hand side. I will have a sign up to warn about camp gate being close.

Coming east From Colusa; Take Hwy 20 Towards Meridian, turn left onto 4th St in Meridian, this turns into Mawson Rd. Turn right on Pass Rd. Camp will be in a pasture on the Right-hand side. I will have a sign up to warn about camp gate being close.

Sutter Buttes Endurance Ride Agreement & release of Liability

I am aware that participating in these events involves the risk of injury to my person and property, involves being in remote areas for extended periods of time, far from communications, transportations, medical facilities: that these areas have any natural and manmade hazards which ride management cannot anticipate, identify, modify or eliminate, that accidents can happen to anyone at any time. I voluntarily accept all risk of personal injury (including death), and property damage arising from my attendance and participation in these events.

As lawful consideration for being permitted to participate in these events, I hereby agree that I, my heirs, personal representatives, and assigns will not make a claim against or sue the Sutter Buttes Endurance ride, its employees, officers, directors, members, agents, or affiliated entities for any injury or damage arising from the negligence of others acts, however caused, of the Sutter Buttes Endurance Ride, its employees, officers, directors, members, agents, contractors, guests, invitees, etc.

In addition, I Hereby release and discharge The Sutter Buttes Endurance Ride , its employees, officers, directors, members, agents, contractors, guests, invitees, etc. from all actions, claims or demands, that I, me hears, personal representatives or assigns now have or may hereafter have for injuries or property damage resulting from my participation in the Sutter Buttes Endurance Rid. I agree that this release includes injury or damage caused in whole or in part by negligence, active or passive, of the Sutter Buttes Endurance Ride and its members, employees, landowners, agents, and contracting parties. I have carefully read this agreement. I understand that this is the complete release of Liability and a promise not to sure or to make a claim.
