DIRECTIONS: From I-65 take Exit 19. Turn west on SR 160. Go approximately 5.5 miles and turn left onto Pixley Knob Road for 1.4 miles. Then turn right onto Flatwood Road for 1.4 miles and camp will be on your right.

You must have an Indiana bridle tag to ride in the State Forest. Annuals are \$20 and are good for at any Indiana State Park or Forest, or you can buy daily ones for \$5. You need to let me know by May 24 if you want me to purchase either for you.

JUNIORS MUST WEAR HELMETS AND ALL RIDERS ARE ENCOURAGED TO WEAR HELMETS.

Trail: Alternating flat and hills, areas of gravel road, some blacktop. Hoof protection recommended.
