Limited Distance – 4 Days – 25 Miles/Day – 2 days – 30 Miles/Day
Ride Any or All Days

SPECIAL INTRODUCTORY RIDES

All Days – 12-15 Mile Ride
Check in the night before or ride morning
Ride Briefing before ride morning
Ride Start Time – 8:00am

BASE CAMP

One Base Camp for all 6 Days
Potable Water Available Throughout Base Camp
RV Dump Station (BLM fee for use)

FOOD

One Meal Each Ride Day Included in Entry

CHECK-IN

For Day 1 – July 11 starting at 3:00 MDT
For Day 4 – July 15 starting at 5:00 MDT
All Other Days – The Afternoon before the Ride

THE VETS

All fees for treatment other than ride inspections are the responsibility of the rider

BLM

Base Camp and All Trails on BLM Land
Observe All Posted Speed Limits/Signs
No Open Fires (Other Fire Restrictions may apply)
NO SMOKING OUTSIDE OF PERSONNEL VEHICLES

FARRIER

A farrier will be available at Base Camp
All fees are the responsibility of the rider

THE RULES

Current AERC rules apply

Equines are not to be loose in base camp

Equines must be shod or equipped with alternate hoof protection

DOGS

Dogs are welcome but must be kept at owners camp site at all times unless on a leash

No dogs, even on leashes, at the meal area or in the ride office

STALLS CLEANED

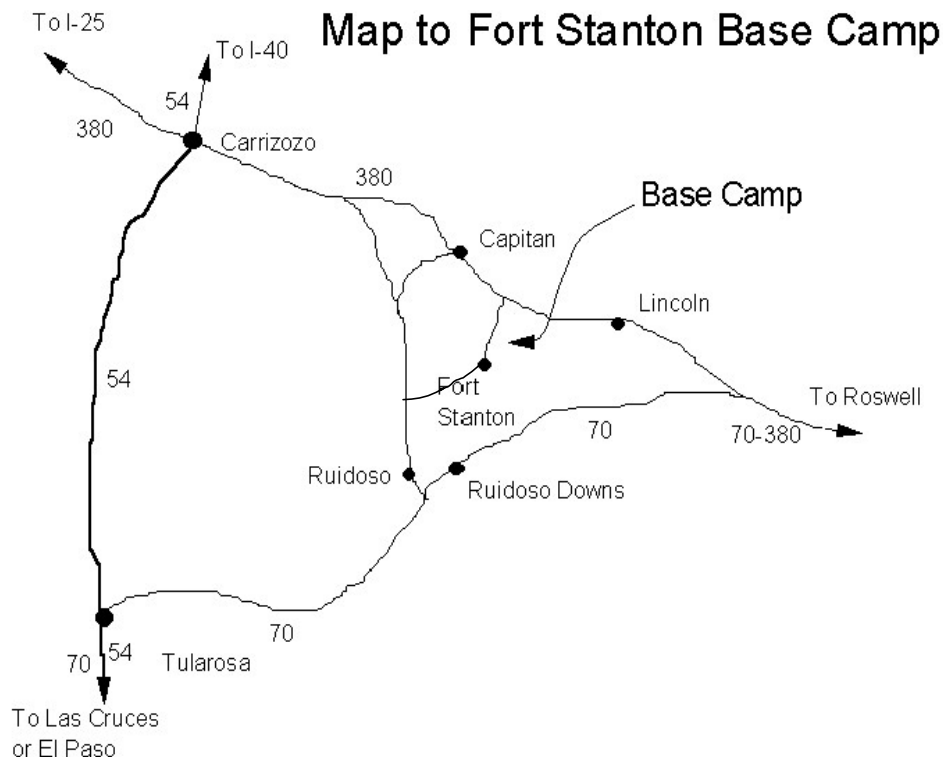
