### DIRECTIONS:

**From the West:** Take Interstate I-44 to exit 129 MO-32/MO- 5 toward Hartville. Turn southeast, then immediately turn left at the stop light to follow 32 E. Stay on 32E approximately 15 miles. At K highway, turn left. Follow K highway 4 miles to AC highway. Turn right onto Flagstone Rd (gravel) at the intersection of K and AC. Follow for 1.1 miles. At the "Y" turn left onto Village Rd. Camp will be 0.3 more miles on your right.

**From the East:** take I-44 west to the Hwy 133 exit. It's the same exit as the Oasis Truck Port. Turn left and go over the bridge. Turn left onto Hwy AB. Drive just several feet and make a right onto Spring Road, the first road on the right you come to. Follow Spring Road to Hwy K (the first paved road on the left) and turn left. Drive on Hwy K until you get to the junction of Hwy K, Hwy AC, and Flagstone Road. Turn left onto Flagstone Road. Follow for 1.1 miles. At the "Y" turn left onto Village Rd. Camp will be 0.3 more miles on your right.

### CAMPGROUND:

This is a primitive campground. No running water or electricity. Horse water will be provided. There is also a small pond. Space is limited. Trash is packed out with you.

### RULES:

- AERC Rules strictly enforced
- Manure/Hay spread in surrounding woods area
- Dogs on leashes

As a condition precedent to my participation in this activity, I agree to take full responsibility for myself, my children, animals and property. I further agree to hold harmless AERC and OCER and their respective officers, directors, members, volunteers, sponsors, participants, and/or premise owners of all properties where the activity(ies) take place (hereinafter collectively referred to as "The Released Parties"), and further agree I will not bring a claim, suit or litigation of any nature against the Released Parties for any damages I suffer, economic or non-economic, which relates in any manner to my participation and/or involvement in this activity, including those instances arising from the alleged negligence of the Released Parties.
