John Parke: Rule 14.3 Mediation is now a required part of the protest procedure.

The Chairman of the P&G Committee shall first refer all protest to mediation, this includes positive drug test. Protests are between two individuals the protestor and respondent and could be resolved with non- binding

mediation. With a positive drug test, a protest is filed by the Executive Director on behalf of AERC against rider and horse. The process needs to be looked at on who will represent AERC in mediation. After discussion the Rules Committee will look at the process and advise the BOD at the March 8th AERC Convention Board meeting.

The Veterinary Committee will also be working at the drug testing procedures. Also looking at drug levels and thresholds on naturally a curing and environmental contamination.

Paul Latiolais will be sending a letter to USEF on behalf of the AERC members and the BOD with outrage on the recent horse deaths and horse welfare abuse in some Group 7 nations endurance rides. He asked the Board to approve at Ad Hoc committee to help write this letter. The committee will be Christoph Schork, Monica Chapman, Mary Howell, with advice from Jan Stevens and Michael Campbell. The letter will go Executive Committee before being sent. When USEF has a chance to read it the letter will be put on AERC website and Facebook. Approved
