AERC General Session February 25, 2023

President Nick Kohut DVM called the meeting to order at 12:05 p.m. EST

Nick Kohut DVM welcomed everyone to the AERC convention and thanked the AERC office staff and their families who have been working the conventions for over twenty years. He thanked outgoing Board members Tami Rougeau and Christoph Schork for their work on the Board and has confidence that they will continue working with AERC by sitting on committees. Trails and membership growth are big concerns. He is hopeful for a calm year that will allow us to work more on the important issues.
