Sinking Jim's has a large pavilion with showers and bathrooms. A variety of cabins can be rented, as well as partial (water/electric) hookup options with covered or uncovered stalls. (HOOKUPS MUST STALL).

Primitive options are available in the back field and horses are allowed to be housed by your trailer (hi tie, portables corrals, ect) You **must** be in the back field and cannot block a hook up. Special Endurance Pricing available to **PRIMITIVE ONLY** is \$30 per rig for the weekend (Fri, 10<sup>th</sup> –Sunday, 12<sup>th</sup>). Please spread out any compostable waste and pick up any and all plastic/garbage.

Terrain: Terrain can be technical at times with rolling hills and lots of short elevation changes. Some gravel stretches. Lots of tree roots. Hoof Protection recommended.

Activities: Registration will be held at the "Stinking Jim's" pavilion across from the swing set/fire pit.

Ride Meetings, Awards, and Friday's dinner will be held at the main pavilion. The showers and restrooms are located on the back side of this pavilion with the entry doors on the outside.

Friday's dinner is \$10 a plate featuring southern cooking and lots of options. You pay at time of service but I will need a rough head count so we know how many people to expect. Saturdays Lunch will be catered by Trippy Reds Food Truck.

## RIDER LIABILITY RELEASE: Witch Dance Endurance Ride 2024

The Undersigned acknowledges that distance horseback riding is a sport which carries an inherent risk, which means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following:

- (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- (b) The unpredictability of an equine's reaction to sounds, sudden movements, unfamiliar objects, persons, motorized vehicles, or other animals;
- (c) Hazards, including, but not limited to, surface or subsurface conditions;
- (d) A collision with another equine, another animal, a person, or an object;
- (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

The Undersigned, in consideration of acceptance of his/her entry in this ride, does hereby for himself/herself, his/her heirs, executors and administrators, waive and release all ride personnel and the sanctioning Ride Organizations, their officers, and all individual members thereof, and all other persons, regardless of their capacity, in any way connected with this event, their representatives, heirs, executors, administrators and assigns for any and all right, claim or liability of any kind or nature the Undersigned might have. Further, the Undersigned does hereby acknowledge that said release will extend to any accidents, damages or claims arising out of his/her entry caused by his/her own acts or anyone or any animal within his/her control.
