Vet-in 5:00 PM. Ride start 7:00 AM each day.

Fees: 50 miles: \$100. 30 miles: \$80. 14 mile: \$50. Juniors half price.

Limited entries. Exact number will be determined by how many horses in each rig / ride. Please pre-enter by 8/10/2017. After that, contact Mickie for availability.

Terrain: Mostly flat, with some rolling hills and a few steep climbs. A fair amount of 2-track, so please plan your ride accordingly. Good water, very little crew area on trail.

Camping: There are 30 official sites, and we are allowed to double up on the larger ones, and I have reserved the connected group camp for overflow. So there's plenty of room, but please keep corrals a decent size to be kind to your neighbors. Camping is \$20 per night; YOU MUST RESERVE through the Reserveohio.com site. If sites are full, contact ride management for availability of space in the group camp (that will be paid to ride management).

Directions: From I-71, go west on SR 73 to Furnas-Ogelsby Rd, and turn right. From I-75 or SR 42, go east on SR 73 to Furnas-Ogelsby Rd and turn left. *There may be construction on the bridge but traffic is maintained.* Go approximately 2 miles, past the sign for Horseman's Group Camp to the Horseman's Camp. There will be a ride sign near the park sign.

The Undersigned, in consideration of acceptance of his/her entry in this ride, does hereby for himself/herself, his/her heirs, executors and administrators, waive and release all ride personnel and the sanctioning Ride Organizations, their officers, and all individual members thereof, and all other persons, regardless of their capacity, in any way connected with this event, their representatives, heirs, executors, administrators and assigns for any and all right, claim or liability of any kind or nature the Undersigned might have. Further, the Undersigned does hereby acknowledge that said release will extend to any accidents, damages or claims arising out of his/her entry caused by his/her own acts or anyone or any animal within his/her control.
