The Hog Scramble ride is being held as a benefit ride, with all profits being donated to the equestrian division of the Sam Houston Trails Coalition. Funds will be used in maintaining and expanding the Richards-Raven Equestrian Trails, on which the ride is held.

Ridecamp: Camp opens at 9 am Friday morning. Camp closes at 10 am Monday morning. Camp is on private property, with a large open field with plenty of room for primitive camping. There will be water for horses, but NO people water, so bring your own. We will have an all-night generator area; please watch for signs when arriving and parking. Please spread your hay and manure thoroughly. Please pack out all of your people trash.

The Gate: The entrance gate MUST be kept closed at all times, as the landowner has exotic deer that he doesn't want to escape. We will try to always have someone at the gate to open and close it, or to monitor it for deer. But if you happen to arrive and no one is there, you MUST close it behind you. Failure to do so will result in us not being able to hold the ride in the future. The gate will be manned at all times during the ride.

Trails: The ride will be held on the Richards-Raven Equestrian Trails. The terrain is slightly rolling but not excessively hilly. This is a relatively new trail, so there are minimal roots and virtually no rutting. The trail surface is barefoot friendly. A few very short sections have been reinforced with gravel. The ride will go down gravel Forest Service roads for short distances at times, hence the recommendation for hoof protection. All vet checks will be in camp.

Ride Rules: The ride will be conducted in accordance with AERC and TERA rules. Riders must check in during roll call before heading out on trail, and must leave camp within 15 minutes of start time. Junior riders must wear helmets at all times while mounted, including in camp. Ties will be recorded at the finish *only* if finish line personnel are unable to distinguish finish order. Negative Coggins required on all equines entering the property. Riders are responsible for any vet fees that may be individually incurred. If you decide to RO, you must let the timers know, and must obtain a final vet check for your horse. Dogs – I just ask that you be a responsible dog owner. Don't let your dog go pee on your neighbor's stuff, harass their dog, etc. Keep them under reasonable control. One firm rule...NO dogs in the vet check or P&R areas (except the timers' dogs).

Intro Riders: The Intro Ride offers an opportunity for newcomers to see what endurance is all about. Intro riders will complete a loop of approximately 10 - 13 miles and have a pre-and post-ride vet check. There is no time limit for completion. There are no placements, and results are not reported to AERC. However if your horse successfully completes the ride, you will receive a completion award and have had the opportunity to experience the sport of endurance. NOTE: If you do not plan to camp Friday night, but plan to ride Saturday, please attend the Friday night Pre-ride Meeting. It will be very beneficial in understanding the sport and outline of the ride. You can arrive early Saturday or Sunday and vet your horse after the 30s start their ride.

Directions:

Do not follow your GPS...it will take you to the wrong 209 road and you will either get lost or end up on a long round-about trip on gravel roads!

From the North, take exit # 118 from I-45. Turn left onto the feeder road/Hwy 75. At the light, turn right (west) on FM 1791 and go approximately 13.0 miles and turn right at the sign for Richards-Raven Equestrian Trailhead. Go 1.3 miles. At the Y, bear right and go approximately 1.0 mile. Turn right and proceed to gate. Go through gate and follow signs to camp.

From the South, take exit # 102 from I-45 in New Waverly. Go west on FM 1375 at the roundabout (go under I-45) for about 13.7 miles to FM 149. Turn right on FM 149, go 1.3 miles. Turn right on FM 1791, go 4.1 miles. Turn left at the sign for Richards-Raven Equestrian Trailhead, and go 1.3 miles. At the Y, bear right and go approximately 1.0 mile. Turn right and proceed to gate. Go through gate and follow signs to camp.

There should be plenty of parking. Watch for the all-night generator area signs. This area will be along the right-hand side of the field, along the fence. Everywhere else, it will be generators off at 10 pm. There are fire ants here and there in the field (not bad), so you may want to bring some fire ant killer with you.

No unentered horses on trail Saturday or Sunday!
