CAMPING: Saddle Ridge has 34 campsites with corrals or tie posts. Bathroom and shower facilities are onsite as well as horse water and wash rack. Check-in & checkout is 2:00 pm daily

CAMPSITE RESERVATIONS: Contact the Hillsdale Park Office directly at 913-594-3600.
*Electric/water sites: \$22 per night, *Water only sites: \$10 per night, *Primitive camping available. *Daily vehicle permit of \$5, *Transaction fee \$3.

DIRECTIONS: From the South and West: Take I-35N towards Kansas City. Take the KS-68 exit toward Ottawa/Louisburg. Turn right onto KS-68. Turn Left onto Osawatomie Rd. After you cross the dam turn left on Harmony Road (go about .3 miles). Turn left onto W. 253rd St. (go about .2 miles). Saddle Ridge is on the right. From the North and East: Take I-35S. Take the US-169 S, exit 215 towards Paola/Hillsdale Lake. Turn left onto US-169S (go about 13.5 miles). Take the 255th Street ramp. Turn right onto W. 255th St (go about

2.5 miles). Turn right onto Harmony Road (go about .3 miles). Turn left onto W. 253rd St. (about .2 miles). Saddle Ridge is on the right.

ONLINE REGISTRATION: Preregistration entry requested by October 5th. Since entries are limited showing up the weekend of the ride does not guarantee entry to the ride and will have a late fee. Since this is a benefit ride there are no refunds. You may use the JOTFORM to preregister(jot form link <https://form.jotform.com/242517347717158>) or send below form via mail. JUNIOR RIDERS: are those who are 15 or younger as of the first day of the new ride year (December 1, 2023) and must be accompanied by an adult sponsor throughout the ride. A helmet is also required while mounted. If the junior has no sponsor before the ride, please contact management and often a sponsor can be arranged.

INTRODUCTORY RIDERS: The purpose of the Introductory Ride is to give a new rider or equine a chance to experience the sport of endurance. The equine must be at least 48 months old but there is no age limit on the rider! There will be a standard vet exam. The non-AERC member fee does not apply. This is a fun and low key way to get to know our sport.
