

# Fall Fiesta Endurance Ride

October 4-5, 2025



Welcome to the Fall Fiesta Endurance Ride! We will be on a large private ranch just three miles north of Los Olivos in the Santa Ynez Valley next to Michael Jackson's former Neverland Ranch. This will be the first endurance ride ever on this ranch. The trail winds through oak dotted rolling hills with spectacular views. The terrain will be more gentle than my other rides. No loop is longer than 13 miles and no climb exceeds 350 feet of elevation gain.

This ride will be a good choice for beginning riders and horses. We will have 50 mile, 25 mile and Introductory courses each day. Nearby Los Olivos is well known for its numerous restaurants and wine tasting rooms, including the famous Mattei's Tavern first established in 1886 as a stagecoach stop.

From the north, take Highway 101 exiting onto the northern end of Highway 154 before you reach Buellton and turning left onto Figueroa Mountain Rd as you reach Los Olivos. From the south, take Highway 101 exiting onto the southern end of Highway 154 in Santa Barbara and turning right onto Figueroa Mountain Rd as you reach Los Olivos. Turn right through the marked ranch gate 2.85 miles up Figueroa Mountain Rd and follow the ribbons to camp. The ranch gate will be unlocked and camp opened Friday at 8 am, October 3.



Please fill out the attached entry form and liability release for the Ride and return them to me by email or regular mail as directed on the entry form. You may pay by PayPal to [jhparke@icloud.com](mailto:jhparke@icloud.com) or by check payable to John Parke. Daily entry fees are \$145 for the 50 and LD rides and \$100 for introductory rides. Pay another \$20 per day for 50/LD if not an AERC member. There will also be a late fee of \$65 for entries received after September 28, 2025. A \$65 charge will be deducted from any refunds for cancellations made after September 28, 2025. No refunds for cancellations on Ride days.

## **Fall Fiesta Ride Liability Release and Waiver**

By signing this form, you are waiving, and releasing the ride manager of the Fall Fiesta Endurance Ride (the "Ride"), John Parke, all ride personnel, the American Endurance Ride Conference, and all owners and lessees of the land where the Ride may take place including, but not limited to, the Ted Chamberlin Ranch, Ted Chamberlin Ranch, LLC, Chamberlin Ranch, LLC, Chamberlin Ranch Limited Partnership, and Chamberlin Los Olivos LLC (collectively referred to as "the Releasees") from all claims of liability as described below. Please read these legal terms carefully and sign to indicate your agreement. This agreement is governed by California law.

### **Agreement**

**Risk.** In consideration of receiving permission to participate in the Ride, I agree as follows: I understand that endurance riding involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; that these areas have many natural and man-made hazards which ride management cannot anticipate, identify, modify, or eliminate; that horses can be excitable, difficult to control, and unpredictable; and that accidents can happen to anyone at any time. I understand that the Ride may involve unavoidable risks, and that difficult and dangerous conditions or unanticipated hazards may be encountered. I also understand that accidents or injuries may occur in locations or circumstances where medical attention is not readily available and that the Releasees cannot guarantee availability or quality of emergency medical services. I am unaware of any reasons why I would physically be unable to participate safely in the Ride. While on the Ride and traveling to and from the Ride, I agree to take full responsibility for myself and the animal I am riding and to take all reasonable precautions to avoid injury to myself and others and to avoid damaging property, habitat, or wildlife.

I ACKNOWLEDGE THAT THE RELEASEES MAKE NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, REGARDING THE SAFETY OF THE RIDE, THE SAFETY OF NATURAL CONDITIONS AND WILDLIFE, THE SAFETY OR CONDITION OF ANY PLACE WHERE THE RIDE IS LOCATED, OR THE SAFETY OR CONDITION OF ANY EQUIPMENT OR MATERIALS PROVIDED BY THE RELEASEES IN CONNECTION WITH THE RIDE. I AGREE TO PARTICIPATE IN THE RIDE ENTIRELY AT MY OWN RISK AND TO ASSUME ALL ASSOCIATED LOSSES AND LIABILITIES.

**Release & Waiver.** I further agree to release the Releasees and their officers, directors, employees, trustees, volunteers, and agents, from any and all liability for any injury or damage to me or any other person or property, or for my death or the death of any other person which may occur in connection with the Ride or my participation or during my presence on or travel to or from the Ride. I intend this release to be effective, to the maximum extent permitted by applicable law, regardless of whether the claim of liability is asserted in negligence, strict

liability in tort, or other theory of recovery. For myself, my estate and personal representative, my heirs and assigns, I agree (1) to make no claim, nor to institute any suit, action or proceeding against the Releasees, or their officers, directors, trustees, employees, volunteers, or agents relating to any accident, incident or occurrence in connection with the Ride or my participation, or during my presence on or travel to or from the Ride and (2) to indemnify, defend and hold harmless the Releasees, and their officers, directors, trustees, employees, volunteers and agents from any and all losses, claims, damages, penalties, liabilities, demands, costs and expenses (including, without limitation, litigation costs and attorneys' fees), to the extent arising from any injury or damage to me or any other person or property, or from my death or the death of any other person in connection with the Ride or my participation, or during my presence on or travel to or from the Ride. Notwithstanding the foregoing, nothing herein shall be deemed to waive or release the Releasees from any liability to the extent such waiver or release would be void against public policy. California law shall govern this Liability Release and Waiver agreement. I agree that this liability and release waiver extends to all claims of every kind and nature whatsoever whether known or unknown and expressly waive any benefits of California Civil Section 1542 which states:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."
