#### **Entries & Fees**

Entries, with a minimum \$25.00 non-refundable deposit, must be received by **October 11, 2025** in order to avoid a \$25.00 "on-site" / late registration fee. "On-site" / late registration fee applies to both online and mailed entries not received "in hand" by **October 11, 2025**. Your entry will not be considered valid until the \$25.00 deposit or payment in full has been received.

Must have a minimum of 11 entries in the 100 Mile distance. If the minimum is not met by **October 4, 2025**, entry fees and / or deposits will be fully refunded or may be applied to an alternate distance. **(Applies only to 100 mile distance)** 

RIDE CAMP - GPS Coordinates 30\*40′51″ N 89\*02′20″ W Ride camp is primitive camping area with flat easy parking. There will be water available for horses but no people water. Some trees are available in some areas of camp for those who high tie. Port-a-lets will be available. No dumpsters available, so if you pack it in, please pack it out. Parking may be tight, so try and minimize your footprint. No generator cut off time due to 100 milers being out. Efforts will be taken to park all 100 Milers in same general area close to vet check. However, if this is not feasible, be considerate of neighbors and coordinate among yourselves. There will be a farrier on grounds.

## ALL vet checks will occur in camp.

**TRAILS** - Trails are permanent forestry horse trails with very little sand, low gentle rolling hills with some hardwood bottoms. There will be some dirt & gravel roads, some with shoulders. Shoes or boots are recommended. Plenty of water available on trail with some shallow water crossings pending rain.

## **Two Same Day Separate LD Rides:**

- 1. Both rider and horse may participate in both.
- 2. Rider may ride both on two separate horses
- 3. Horse may participate in both with two separate riders

The two LD rides will be separate rides NOT Elevator

#### **DRIVING DIRECTIONS**

GPS Coordinates to Ride Camp 30\*40'51" N 89\*02'20" W

- From the East Interstate 10 west to Exit 46D-B. Go north on Hwy MS15 / MS 67 for about 13.8 miles. Turn right onto Success Rd. for about 4-1/2 miles. Go Straight at 4-way for 3 miles. Big Foot Horse Trails sign on right
- From the West Interstate 10 east to Exit 38. Go north on Hwy MS 605 for about 8 miles. Exit onto Hwy MS 67 North go about 2.6 miles. Turn right onto Success Rd. for about 4-1/2 miles. Go Straight at 4-way for 3 miles to Big Foot Horse Trails sign on right
- From the North Interstate 59 South to Exit 59 (US Hwy 98 East). Go 3 miles, exit onto Hwy 49 South. Go approximately 39 miles. Turn left onto East McHenry Rd. (You will see McHenry WMA Shooting Facility sign and AERC signs located about ¼ mile past Chevron station & Pecan House on the right side of Hwy 49). Go 4 miles to intersection (church located across road & AERC signs present). Turn right, go 1.8 miles, Big Foot Horse Trails sign on left.

As a participant in the Hunting for Bigfoot Endurance Ride on October 18, 2025, I hereby agree to comply with any rules of AERC, SERA, SEDRA and the conditions and regulations of this event. I understand that endurance riding involves being in remote areas for extended periods of time, far from communications, transportation and medical facilities, that these areas have many natural and manmade hazards which ride management cannot anticipate, identify, modify or eliminate. I understand that horses can be excitable, difficult to control and unpredictable, and that accidents can happen to anyone at anytime. I assume full responsibility for myself and the animal I am riding or in my care. I will hold AERC, SERA, SEDRA, it's officers and all individual members thereof, all ride personnel, and property owners over whose land I may cross, their representatives, successors and assigns, blameless for any accident, injury or loss that may occur due to my participation in the Hunting for Bigfoot Endurance Ride. I further agree to hold any and all of the aforementioned individuals and organizations free from all liability for such injury or loss. This release extends to all claims of every kind and nature whatsoever, whether known or unknown, and I expressively waive any benefits that I may otherwise have under the provisions of the laws of Mississippi relating to the release of unknown claims. I understand that this release constitutes a limitation upon my legal rights.

UNDER MISSISSIPPI LAW ( $Code \S 95-11-5$ ), AN EQUINE ACTIVITY SPONSOR OR EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.

The undersigned verified acceptance for risks and responsibility for rider's and horse conditions and certifies that all information on this form is correct to the best of his/her knowledge.

I give consent for and will be financially responsible for emergency medical treatment for myself and/or the horse that I am riding or is in my care if I am unable to give informed consent.
