Giulia Orth briefed the Board on AERC Office updates. Key points from the discussion:

· Installation of Authorize.net software for credit card processing compliance is underway and implementation is expected by the end of the month.

- The Employee Handbook is under review by a California nonprofit employment law team; feedback is anticipated in two weeks.
- A full-time Member Services Coordinator position was posted on LinkedIn and local community boards for a mid-late September start. Some applicants have been received.
- · Vote to approve the new employee position be open to AERC members, with confidentiality agreements required. Passed with one opposed.
- · Vote to shred paper records prior to 2024, currently stored electronically on website and SharePoint. Credit cards numbers will not be stored. Passed with one abstention.
- · Vote for ride results, sanction applications and membership records to be moved to digital-only storage; hard copies will be printed only as needed. Passed unanimously.
- · Mollie Krumlaw-Smith made a motion, which was seconded by Jan Stevens, to postpone membership increases and reconsider in 2026. Motion passed unanimously.

Insurance Discussion

Diane Lesher, President of Equisure, summarized and explained AERC's general liability insurance policy, Directors and Officers (D&O) liability insurance policy, and member-purchasable excess equine liability insurance. She will check premiums for internet, cyber, and crime liability coverages and update the Board. Equisure has reliably supported AERC for over 15 years with consistent policies and we appreciate Diane Lesher.

Written reports were submitted by both the Education and Membership Committees. There was nothing new to report on from Sanctioning and Welfare of the Horse Committees.

John Parke made a motion, which was seconded by Vance Stine, to enter executive session at 9:03 p.m.

Mollie Krumlaw-Smith made a motion, which was seconded by Tami Rougeau, to exit executive session at 9:35 p.m.

In regard to the 2024 AERC National Championship Ride, it was discussed and agreed that all related revenue and expenses related to the National Championship ride be covered by the ride manager.

Susan Kasemeyer made a motion, which was seconded by Khristin Seymore-Norsworthy to adjourn at 9:37 p.m. Motion passed.
