## Financial Policies for TWHR 2025

The following are the financial policies for this year's ride (these apply ONLY to TWHR 2025 held on October 3 and 4):

- Your ride fee will include a non-refundable component or, if you prefer, a "deposit" of \$35 for each ride entry. If the ride is cancelled for any reason, your entry fee will be returned to you minus the \$35. This will ensure that ride management can pay for "up-front" and "nonrefundable" expenses in a businesslike manner.
- Once your horse passes the pre-ride vet check, you are deemed to have entered the ride for purposes of your entry fee. No ride entry refunds will be given once your horse passes this check. If your horse does not pass the pre-ride vet check, your entry fee will be refunded minus the \$35. As always, the vets will make the final decision regarding whether your horse passes this check.
- Entry fees for the 25 and 50 mile distance will be \$120 if your payment is received on or before September14<sup>th</sup>, and \$135 for payments received between September 15<sup>th</sup> and September 22<sup>nd</sup>. If your payment is not received by September 22<sup>nd</sup>, you must pay at the ride (check or cash). On-site ride fee is \$145.

As I'm sure all of you realize, conducting endurance rides in these times is a business which requires many hours of preparation and significant up-front expense. Riders must assume a greater share of these risks if our sport is to continue. We need to recruit and train new ride managers, and a key component of doing so is minimizing their financial risk. #### Directions to The Whole Hog Redux (TWHR)

The headquarters and ride site for TWHR will be the Valley View Group Use Facility at the LBJ Grasslands. If you have been here before, you probably have your favorite route; and all of you probably have access to a good GPS. Here are a couple of suggestions if you need them.

<u>From the West, South, or East</u>: Take US 380 to Decatur. Exit to FM 730. Take FM 730 north approximately 9.2 miles to CR 2461. Turn left on CR 2461, and then take an immediate right on CR 2560. Proceed approximately 4.7 miles to the junction of CR 2560 and CR 2675. Continue straight on CR 2675 for 2 miles to the entrance to Valley View Campground on your right.

<u>From the North</u>: Proceed to the city of Era, TX (consult your map). From Era, take SH 51 southwest to FM 455, about 12 miles. Turn right on FM 455 and proceed to FM 730, about 7.2 miles. Turn left on FM 730 and proceed south to CR 2461, about 7.6 miles. Turn right on CR 2461, and then take an immediate right on CR 2560. Proceed approximately 4.7 miles to the junction of CR 2560 and CR 2675. Continue straight on CR 2675 for 2 miles to the entrance to Valley View Campground on your right.

NOTE: If you come through the Decatur area, watch your speed, as there are always city and county law enforcement officers monitoring the roads.

There should be ample parking for everyone, but a monitor will be on hand to help you park.

**TRAILS**: The ride will be held on the trails of the LBJ National Grasslands, operated by the U.S. Forest Service. The terrain is gently rolling and varies from open meadows to some forested areas; it is not considered "technical". You may encounter some sandy areas. The trail surface is considered barefoot friendly, although you should consider shoes or boots.

Trails are permanently marked and easily visible; additional trail markings will be provided where needed. The trails we will use are loops, and all vet checks will be held in camp

RULES: Endurance is an athletic event for both horse and rider. The goal is to complete the marked trail within the time given as established by AERC standards with an equine that is fit to continue from checkpoint to checkpoint. Equines must pass a complete vet check before, during, and after the ride. All AERC rules will apply. Safety helmets are recommended for all riders, but are required for juniors at any time they are on their equine, in camp or on trail. Junior riders must be accompanied by a designated adult sponsor (21 years or older) at all times during the ride. Juniors riding as Seniors must show AERC approval.

**GATE HOURS**: Camp will open on Thursday at 10:00am, and close Monday at 10:00 am. Water *for horses only* is available in camp. Riders, please bring your own water for your consumption. Vet checks will be in camp.

ALL manure and hay must be spread nicely! Human trash must be packed out – no dumpster available!!

CAMPING: The camping fee and day rider fee is included in your ride entry for Thursday and Friday only. You are responsible for your camping fee if you arrive before Thursday (or Saturday if you stay over until Sunday). This fee is \$10 fee per vehicle per day. You must pay these fees to the US Forest Service directly; a drop box is available to deposit your payment. There are no hookups available.

## **REGION 9 ENDURANCE CHAMPIONSHIP**

AHA Region IX 50 mile Endurance Championship October 4, 2025 LBJ Grasslands, Decatur, TX Sanctioned by AHA & AERC





The Region 9 Endurance Championship is being held in conjunction with THE WHOLE HOG REDUX 2025 AERC ride.

Camping: This is a primitive base camp on a small hill with a thick stand of hardwood trees and a scenic pond & windmill for horse water. There is ample room for campers; however, no electricity or people water is available. Rest room facilities are provided. Dogs must be on a leash at all times. There are restaurants, motels and stores in Decatur.

**Trails:** The ride is considered easy terrain. Trails vary from fast flat areas, to high open areas with panoramic views, to deeply wooded forest. All trail is natural, with roadway's used only for crossings. There should be ample horse water on trail. Shoes are not required; however, they are recommended. All vet checks will be in base camp. All trails are permanently marked. The weather in the October can range from cool & rainy to hot & dry. This is Texas where we have quite the weather ranges.

No steward is required for this ride

#### HOW TO QUALIFY FOR AHA REGION 9 CHAMPIONSHIP RIDE

#### **HORSE:**

- 1. Must be qualified by having successfully completing at least 100 lifetime miles of competition. (See 2025 handbook)
- 2. Must be a registered Arabian, Half Arabian or Anglo Arabian. Horse must be at least 60 months of age, ridden and owned by a current member of AHA.(Owner and rider need not be same)
  - 3. A current negative Coggins test is required.
- 4. Copies of registration papers (front & back) and AHA competition membership cards(owner and rider) <u>must</u> be presented.

#### **RIDER AND OWNER:**

Both rider and owner must be current competition members of AHA, and cards must be shown for entry into ride.
