Entry: *Preferred method of entry is online* We request entries, waivers, and payments to be received October 27th, 2025. Mailed in entries will only be accepted until Oct 27th 2025. After Oct 27th 2025 online only and with a \$25.00 late fee. We are offering a \$20.00 discount for junior and young riders (does not apply to fun ride). There is an additional fee of \$20.00 for Non-AERC members.

Cancellation Policy: Cancellations prior to 5:00 pm Monday November 3rd, will receive a full refund. Cancellations after 5:00 pm Monday November 3rd will be charged an administration fee of \$25.00. A no show- no call, will not receive a refund. Once the applicant starts the ride, the entry fee is not refundable. Ride Manager must be notified of cancellation by the start of the ride or no refund will be issued. Please allow 7-10 business days after the ride for a refund to be returned.

Trails: The McDowell Mountain Park trails are multi-use, well maintained with mostly good footing and minimal elevation changes. Each distance will travel through some rocky stretches as well as sand washes. We do recommend hoof protection. The 30 and 50 mile rides will have 1 vet check with a 1 hour hold in basecamp. The 75 mile ride will have 2 vet checks with two 1 hour holds in basecamp. All vet checks will be at base camp. We will designate a crewing area for riders that do not want to go back to their trailer during the hold.

Campsite: The Park gates will only be open from 6:00 am to 8:00 pm. If you have a situation that requires entry after hours contact Stephanie 602-770-5534. For Exit of the park the gate will open by sensor. Base camp is easily accessible and fairly large, but with a 100 + riders it does tend to fill up. To ensure adequate parking for all, please use parking space wisely. There is horse water available for

hauling, Park restrooms, and showers, but no RV hook ups. Pick up your manure, shavings and hay from your campsite. Per McDowell Mt Park's request we will provide a Dumpster on site. Please only use ride designated Dumpster for all trash and manure. If Dumpster is full, you must take it home with you! **No trash is to be left outside of the Dumpster.** Your campsite must be left spotless.

Park Fee: The daily park fee is \$7.00 per vehicle or \$22.00 for overnight camping paid directly to McDowell Mt Park at entry. New is Park restrooms and showers.

Location: The Park is located at 16300 McDowell Mountain Park Dr. MMRP, AZ 85268

30 mile ride: 7 hours and 15 minutes are allowed for completion of the Limited Distance ride. Your time does not stop when you cross the finish line. Your time stops when your horse's heart rate meets the finish criteria of 60 beats per minute.

12 Mile Fun Ride/ Intro ride: The 12 mile ride offers an opportunity for new comers to learn about Endurance. You will get to go thru the process of vetting your horse before and after your ride. Your equine must be 4 years old. Vetting will be available Friday 2:00 pm to 5:00 pm or Saturday 7:30am – 8:00am the day of the ride. The 12-mile ride must be completed in 5 hours elapsed time. Riders under 16 years of age must wear a helmet and be accompanied by a competent adult.

Junior Riders: All junior riders must wear a helmet at all times while on an equine and ride with an adult sponsor. Those juniors who qualify to ride without a sponsor must have appropriate paperwork from AERC.

- Junior and young riders will receive a \$20.00 discount (**does not apply to fun ride**).

Meals: Friday rider dinner included in entry for all distances, extra tickets are available for \$12.00.

Awards: A completion award will be given to each participant who completes the ride including the Fun/Intro riders. We also have Top Ten, Junior, and Turtle awards for the 75, 50 and 30 mile ride. Please make sure you pick up your awards, we will not be mailing them out after the ride.

Dogs: All dogs must be on a leash at all times. Please pick up after your dog. **NO DOGS ALLOWED ON THE TRAIL.**

Weather: The weather for this time of month averages between 70 degrees and 90 degrees.

I wish to enter and participate, crew, volunteer, or offer Veterinarian services in the Lead Follow or Get out of My Way ride to be held on November 8, 2025. I have read and understand the rules, conditions and regulations of this event and I hereby promise to comply with them.

In consideration of acceptance of my entry, participation, volunteerism or Veterinarian service in this event, I acknowledge the inherent risks involved in my activity, I assume those risks and full responsibility for my own safety.

I hereby, for myself, my heirs, and my personal representatives and any other person or entity who may assert a claim, release and waive any and all claims or cause whatsoever, against any and all persons and/or entities their shareholders, directors, officers, members, managers, agents and employees from any and all liability for personal injury, illness, disability, death or property damage arising from or relating to my entry, participation, volunteering or providing veterinarians services in this event. I SPECIFILY AND KNOWINGLY AGREE THAT I EXPRESSLY INTEND TO REALEASE the persons and entities, their shareholders, directors, officers, members, managers, agents, and employees from THEIR OWN NEGLIGENCE.
