**Directions:** Chandler, OK is conveniently located between Oklahoma City and Tulsa on I-44. Take Exit #166 then turn North on Highway 18 and go 1/4 mile to 890 Rd. turn West (left). Go approximately 1 1/2 miles. Do not follow curve, continue West 2 miles into equestrian campground.

**Trails:** Scenic established trails through woods and meadows.

**Camping :** Public restrooms with showers, electric and primitive campsites. Tie poles with limited space for pens at most campsites. Campsites can be reserved through the City of Chandler's website:  
<https://app.fireflyreservations.com/reserve/property/.BellCowLakeOk>. \$22/night for electric, \$11/night for primitive, \$6/rider for trail use.

City of Chandler does require everyone to bag their manure. **BRING LARGE TRASH BAGS FOR MANURE.**

**Registration/Check-in:** Ride registration starts at approximately 2:00 pm on Friday. Vet checks start on Friday afternoon, when vet judge is available

**Entry Fees:** Cash or check payable to Ozark Country Endurance Riders  
50 mile - \$105 / 25 mile - \$95 / Intro - \$50 / All juniors except intro - \$50

**Meals:** Potlucks Friday and Saturday after ride briefings. Main dish provided by OCER Board of Directors.  
We will honk horns to alert you prior to the ride meeting at the shelter at approximately 6:30-7pm / TBD.

**Additional info:** Current negative Coggins paperwork dated within 12 months of ride must be presented for all equines in camp. State of OK requires vet health certificate for all out-of-state equines.  
All dogs **MUST** be on a leash or contained at your campsite at all times. **NO** dogs allowed at ride briefings/potlucks.
