

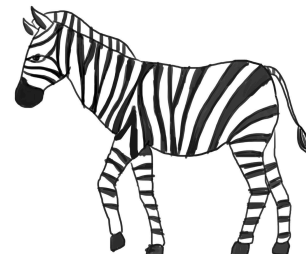

- ★ I will be ride secretary this year; I highly encourage you to PRE-ENTER as I do plan to ride one of the days. 😊 I would hate for you to have to wait on me to complete a 50 in order to get your paperwork and get vetted in. Please plan accordingly. 😊

  - If you cancel for any reason; a \$20 processing fee will be kept, you will receive back all other fees.

  - 75 mile entry is **non-refundable** but can be exchangeable for a different distance.

**Endurance riding** is an athletic event for both horse and rider in which the first goal is to complete the marked trails; and the second goal is to ride this trail as rapidly as the condition of horse and rider allows. A qualified veterinarian and ride manager controls each AERC sanctioned ride to a certain extent. All equines must pass the thorough vet checks before and during the event before they are allowed to continue. After the ride, the equine must pass another thorough check before being allowed a completion.

**Campsite:** Located among the rolling green hills on the outskirts of Mt. Pleasant, Texas, the Priefert Ranch is a family-owned and operated 3,000-acre working ranch. History about the ranch: The ranch runs a cow/calf operation and is also involved

in the commercial hay business. Priefert Ranch is also home to several horses. Two of these magnificent horses are Goliath and Radar, both Guinness World Record holders for Tallest Living Horse. The Priefert Percherons Texas Thunder draft horse hitch is also based on the ranch. It was on this ranch in 1964, that Marvin Priefert built his first headgate. That single piece of ranch equipment became the foundation of one of the of the largest and most respected ranch equipment manufacturing companies in the world. Although Priefert's manufacturing facilities have expanded over the years, the one room shop where Marvin invented his revolutionary side-closing headgate still stands on the ranch and serves as a vivid reminder of where this company has its roots. Today's manufacturing facilities are located adjacent to the ranch, allowing Priefert Ranch to be the first proving ground for the vast majority of Priefert's products. That's why we say Priefert products are "built by ranchers, for ranchers."

**Trails:** The terrain here is flat to gently rolling hills. Trails will go through cattle pastures, creek crossings, and some ravines. All vet checks will be in camp: loop lengths, hold times, and veterinary criteria will be discussed at the pre-ride meeting. Trails are very barefoot friendly! \*This is a cattle working ranch, you will ride though many cow pastures in which cows may or may not be present!

**Intro Riders:** The Intro Ride offers an opportunity for newcomers (riders and/or equines) to see what endurance is all about. Intro riders will complete a loop of approximately 10 - 15 miles and have a pre-and post-ride vet check. There is no minimum or maximum time for completion. There are no point or mileage accumulations, no placement awards, no best condition judging, nor are results reported to AERC. However if your horse successfully completes the ride, you will receive a completion award and have had the opportunity to experience the sport of endurance.

\* Intro Riders are required to have a current, negative coggins. If you do not plan to camp Friday night, but plan to ride Saturday please attend the Friday Night Pre-Ride Meeting because it will be very beneficial in understanding the sport and outline of the ride.

**Directions:**

- Route yourself with your own directions to Mt. Pleasant, Texas.
- Upon approaching Mt. Pleasant, TX; From the SOUTH continue on HWY 271 North (DO NOT TAKE HWY 271 BUSINESS!!). After merging and heading towards Hwy 271 N & I-30 then take the 4000 FM Marvin Priefert Hwy Exit. You will then come to a STOP sign, take a LEFT (going under 271) and head directly into the Priefert Ranch. Follow parking directions.
- Upon approaching Mt. Pleasant, TX; From the NORTH continue on HWY 271 South (DO NOT TAKE HWY 271 BUSINESS!!). After merging and heading towards Hwy 271 S you will take the 4000 FM Marvin Priefert Hwy Exit. You will then come to a STOP sign, take a RIGHT and head directly into the Priefert Ranch. Follow parking directions.
- Upon approaching Mt. Pleasant, TX; If traveling on I-30 exit# 160 onto Hwy 271 South, continue on HWY 271 South (DO NOT TAKE HWY 271 BUSINESS!!). After merging and heading towards Hwy 271 S you will take the 4000 FM Marvin Priefert Hwy Exit. You will then come to a STOP sign, take a RIGHT and head directly into the Priefert Ranch. Follow parking directions.
- If you plan to arrive Wednesday or before Wednesday please call ride management so she can be available to get you parked. PLEASE CALL Khristin @ 903-563-6639!

# Liability Release

As a participant in the Racing Stripes Endurance Ride, I \_\_\_\_\_ agree to abide by the rules of AERC, TERA, and the Racing Stripes ride rules. I understand that endurance riding involves being in remote areas for extended periods of time, far from communication, transportation, and medical facilities, that these areas have many natural or man-made hazards which ride management cannot anticipate, identify, modify or eliminate: that horses can be excitable, difficult to control and unpredictable; and that accidents can happen to anyone at any time. I agree to take full responsibility for myself and the animal I am riding.

I will hold the ride management, all ride personnel, and all property owners over whose land the ride covers, blameless for any accident, injury or loss and free from all liability of such injury or loss that may occur due to my participation in the ride.

I acknowledge that I assume full responsibility for the safety of the equine, my guests and myself. By my signature, I hereby waive all rights to file a claim or lawsuit against the State of Texas, AERC, TERA including all management, ride personnel, and all medical personnel, for any injury or damages which may occur during the time I am at the ride site.

Additionally, I agree to be fully financially responsible for any necessary emergency medical treatment by any medical person or institution in the event of injury or illness. I give my consent for and will be financially responsible for emergency medical treatment for myself, my equine; if I am unable to give informed consent.

## **Ride Rules:**

- NO open camp fires!
- All TACK OFF at all HOLD checks and the FINISH for all distances.
- No more than 2 horses per electric fence.
- All Generators off at 10:00PM, unless parked in all night generator parking. IF you need ALL NIGHT GENERATOR parking MUST contact RM; limited parking.
- Current 'Negative' Coggins test for every equine entering Priefert Ranch.
- Every rider, crew or anyone on Priefert MUST sign a release/waiver form!
- You are responsible for your horse and treatment cost IF needed.
- Absolutely NO SMOKING on trails; disqualification will occur immediately!
- There will be spotters along the trail taking numbers, please speak clearly and wait for the attendant to repeat your number; thus indicating your number has been recorded.
- Any rudeness or "hot" attitudes to ANY volunteers and/or ride management will result in disqualification and immediate removal from the Priefert Ranch.
- Management strongly recommends all riders to wear approved safety helmets while on horseback.
- Please scatter manure and hay before departure.
- Pack all personal trash out of camp.
- All horses within the fenced in PR/vetting area must be at a WALK entering or leaving camp, NO trotting or cantering until outside the fenced area..
- We will also be implementing a "DO IT YOURSELF - DIY" P&R; with assistance if needed. When your horse's heart rate is down, proceed to the master timer where your in/out times will be recorded on the master board and your ride card. At this point you are in the vet line and will proceed to the vet to complete your vet check immediately.
