**Campground:** Hunts meadow is set up to accommodate RV and Tent campers.. Hunts Meadow Campground features 19 RV sites complete with 110, 30 Amp, 50 Amp and fresh water hookups. Each Site includes a picnic table and camp fire ring. You will find tie poles at each site, wash station on south end of campground, pens available for renting for your horses as well as manure pits and wheel barrows for your use.

**Special Note for camp reservations :** Reservations are not available on-line. You must call the office (405) 372-5157 tell them you are attending Indian Territory Endurance ride.

**Trails:** Scenic established trails through woods, meadows and Lakeside.
